The 4-step Procedure with 4-Type of Doc

AHWP Final Documents (including Guidance Documents)

FINAL

- Documents accepted, approved and/or passed resolutions
- Available at AHWP web as AHWP official documents

PROPOSED FINAL

- Documents prepared for approvals and/or resolutions
- Post on AHWP website + circulations → Call for Comments

PROPOSED

- Documents discussed in AHWP and/or TC Meetings
- Post on AHWP website + circulations → Call for Comments

DRAFT

- Initialed by: Chairs of Committees/ WGs / STGs / Secretariat
- Documents discussed within group members

Step 4

b. Secretariat post on AHW

Step 3

- b. Secretariat post on AHWP website under Final Document & Guidance Document
- c. AHWP Guidance Document (as a kind of Final Doc) will bind to all AHWP members
- a. Necessary revision → Label as "(doc name)_PROPOSED FINAL"
- b. WG Chair/Co-chair present in AHWP Annual Meeting for resolutions, and/or approvals
- c. After the meeting: Post on AHWP website + email circulations → Call for Comments
- d. Further revision

Step 2

a. Necessary revision → Label as "(doc name) PROPOSED"

Label as "(doc name) FINAL"

- b. WG Chair/Co-chair present in the TC Meeting
- c. After the meeting: Post on AHWP website + email circulations → Call for Comments

Step

- a. Convert to an AHWP document and label as "(doc name)_DRAFT" (please quote the reference)
- b. Discussed within WG members

Procedure for Documenting an AHWP Reference Document

(no need to go through the 4-step Procedure)

- I. Initialed by: TC/WGs/STGs
- 2. Discussed within group members
- 3. Endorsed by Chair & Co-chair
- 4. Discussed and Endorsed in TC Meeting
- 5. Post on AHWP website under Reference Doc

AHWP Reference Documents are NOT binding to all AHWP members


