(1) CSDT topic:

- 1. Where we are:
  - 1. ASEAN adopted CSDT as requirement for product submission. Singapore HSA also come out with guidance document on how to submit CSDT. CSDT requirement will be implemented in Singapore from April 2009.
- 2. Where GHTF are:
  - 1. New STED document announced in April / May 2008
  - 2. Japan still use previous version of STED
  - 3. Healthcare Canada will promote to use New STED

(1) CSDT: Possible WG01 items

- 1. Comparison of GHTF new STED and ASEAN CSDT
- Come out a finalized CSDT document, propose to AHWP member economy for adoption or propose the adoption of STED
- 3. Invite non-ASEAN countries to pilot implement the CSDT (or STED) requirements
- 4. Share the experience in Singapore of implementing CSDT requirement with other detailed guidance rule surrounding product submission.

Measurement:

No. of AHWP countries adopt and pilot implement CSDT (STED)

(2) Definition of Manufacturer (importer, authorized Rep.)

- 1. Where AHWP are:
  - 1. Diversified definitions in member economies about manufacturers.
  - 2. To cope with the trend of OEM manufacturing and multinational manufacturing, it is beneficial to work out a harmonized definition of manufacturers.
  - 3. Each member economy may have their own definitions of manufacturer in the legal system and it may conflict with the GHTF proposed definitions.
  - 4. The label of "country of origin" may conflict with the GHTF Def.
- 2. Where GHTF are:
  - 1. There is near finalized GHTF guidance document on this topic.
  - 2. This SG1 document is also used and input by other SGs. (SG3)

(2) Definition of Manufacturer:

Possible WG01 items on

- 1. Study and input on GHTF guidance document
- 2. Come out with AHWP guidance document based on GHTF definitions
- 3. Guidance on the issuing of "country's free sale certificate" or "country's export certificate"
- 4. Successful story sharing in AHWP countries on adopting GHTF definitions.

Measurement:

No. of AHWP countries adopting the GHTF's guidance document.
