## Election of New President, Directors of the Board, Treasurer & Vice-Treasurer

### Rules of Election

- Directors shall be members of ASL.
- Directors shall be elected at the annual general meetings
- **Maximum nine (9)** Directors of the Board
- The nine (9) candidates receiving the highest number of votes shall become the Directors. The candidate receiving the greatest number of votes shall become the President.
- The Board shall appoint Directors to be Vice-President, Treasurer, and Vice-Treasurer.
- The Treasurer and Vice-Treasurer shall be persons normally residing in Hong Kong.
- All Directors shall be eligible for re-election at an AGM upon the lapse of their terms of service. The retiring Treasurer and Vice-Treasurer shall not be re-appointed as the Treasurer and/or Vice-Treasurer.

## Eligible Voters

- Voting Member: **Members** (both Regulatory and Industry) of ASL
- Every Voting Member of sound mind and in good standing shall have one vote.
- On a poll, votes may be given in person, by proxy or by any electronic means as prescribed in the meeting agenda.
