- Improve communication among AHWP
 TC WG02 members
 - Set up a fix schedule meetings for AHWP TC WG02
 - Meeting face to face with telecon concurrently
 - 1 day prior TC meeting (Attach with TC meeting)
 - 1-2 months prior to the Annual meeting
 - 1 day prior to the Annual meeting (Attach with Annual meeting)
 - Location: Rotating among AHWP economy members



- Attended GHTF SG 2 meeting in Madrid.
 - SG 2 & 5 joint guidance documents: AE reporting during premarket Clin. Investigat has been up for comment and feedback.
 - Major work items
 - N111 (Definition and classification of Field Safety Corrective Actions -FSCA-, including recalls)
 - Finalization of N87 (electronic transfer of AE between manufacturers and NCAs)
 - SG2 input as ISO liaison for the possible revision of ISO13485 (incl. Post market surveillance section)
 - Future of SG 2
 - CompleteWork Items by December 2012.
 - The National Competent Authorities Reports (NCAR)
 Exchange Program will be maintained.



- 2nd face to face meeting in Hong Kong, November 3-4, 11.
- PMS Survey:
 - Final Report on Current Requirements for Post Market Surveillance & Vigilance System is completed and up on AHWP website
 - No plan to conduct the additional survey
 - Key finding: No harmonization across AHWP economy members



- Review of Implementation of GHTF SG2 Documents status is completed for 7 AHWP economy members.
 - 2 from 7 economy members fully implemented GHTF SG02 documents
 - 2 from 7 economy members have their own guidelines and implemented GHTF SG2 documents less than 10%
 - Across 7 economy members, the timing of AE reporting guideline is the most adopted
 - Plan to use it as an AHWP TC WG02 dashboard to measure WG02 performance
 - Will follow up the rest economy members to complete the survey



- Merge Safety Alert Dissemination System (SADS) and NCAR members
 - 8 AHWP economy members are SADS members
 - 4 AHWP economy members are NCAR members
 - Simplified SADS form (HA need to notify manufacturer prior to dissemination)
 - Create "SADS Online" under http://www.ahwp.info
