

# REPORT OF THE 26<sup>th</sup> MEETING OF THE GLOBAL HARMONIZATION WORKING PARTY (GHWP)

Crowne Plaza Riyadh RDC Hotel & Convention, Riyadh, The Kingdom of Saudi Arabia 16<sup>th</sup> February 2023

# **INTRODUCTION**

(1) The 26<sup>th</sup> Meeting of Global Harmonization Working Party (GHWP) was held on 16<sup>th</sup> February 2023 at Riyadh, The Kingdom of Saudi Arabia. The meeting was chaired by Mr. Ali M. Al-Dalaan, Chair of GHWP, co-chaired by Mr. Gao Guobiao, Vice-Chair of GHWP (Regulatory Authority) and Ms. Tran Quan, Vice-Chair of GHWP (Industry).

## **OPENING CEREMONY**

- (2) Dr. Hisham bin Saad Aljadhey, Chief Executive Officer, Saudi Food and Drug Authority, Kingdom of Saudi Arabia, welcomed all the participants for joining the 26<sup>th</sup> GHWP Meeting in Riyadh, The Kingdom of Saudi Arabia.

Al-Dalaan, Chair of GHWP, declared the endorsement of the guidance document on "Medical Gas System – Essential Principles of Safety and Performance – Standards for Demonstrating Compliance".
