REPORT OF THE 17th MEETING OF THE ASIAN HARMONIZATION WORKING PARTY (AHWP) Taipei International Convention Center (TICC) Chinese Taipei 2-6 November 2012

INTRODUCTION

(1) The 17⁶ Meeting of the Asian Harmonization Working Party (AHWP) was held on 2-6 Nov 2012 at Taipei International Convention Center, Chinese Taipei. The Meeting was chaired by Dr Saleh S.
