- b) According to the House Rules, AHWP primary representatives can be the supporters in this nomination form. Each supporter in Part 3 of the nomination form can support <u>ONLY ONE</u> nominee for each of the position as stated in Part 1 of this nomination form. According to the House Rules, supporter from the same member economy of the nominee is NOT accepted. He/she may vote for another candidate in the election.
- c) Only the submission of nomination with <u>i)</u> completely filled form, <u>ii</u>) email proof support from each of the supporter in Part 3 of this form and <u>iii</u>) a brief CV (maximum 2 pages in A4 size paper) of the nominee will be processed.
